Dear Beloved in Christ,

Greetings in the precious name of our Lord and Saviour Jesus Christ.

The erstwhile IPC Kerala State Council elections were held and the results were declared on August 25, 2022. On February 26, 2025, IPC Kerala State was bifurcated, and IPC Malabar Kerala State was formed consisting of six revenue districts of Kerala State from Palakkad to Kasargod. With this bifurcation, IPC Kerala State now consists only of eight revenue districts from Thiruvananthapuram to Thrissur.

The term of office of IPC Kerala State has come to an end on account of the expiry of its tenure. Considering the expiration of its tenure and also the bifurcation forming IPC Malabar Kerala State, the General Council has decided on February 26, 2025 to appoint Interim Executive Committees in both States to facilitate the transition and to conduct elections. The said Interim Executive Committee is only a makeshift arrangement until elections are conducted.

An Interim Executive Committee under the leadership of Pastor John George, Nilambur, has already been appointed for IPC Malabar Kerala State. Now, in continuation of the decision of the IPC General Council, an Interim Executive Committee is appointed for the IPC Kerala State to oversee the transition until regular elections are conducted.

The Interim Executive Committee for IPC Kerala State, appointed with immediate effect, shall be as follows:

6. Treasurer – Brother Jaimes George, Kottarakkara
